Please call the City of Orlando Permitting Department at (407) 246-2271 for a vendor license. Prior to selling, a food inspection will be performed by the appropriate county agency.

Load In: Food Vendors 8am – 12pm Noon, Non-Food Vendors 3:30 pm – 4pm on **Thursday, Nov 21, 2024**. Vendors can start selling at 6pm on Thursday if inspected.

Load Out: 6:00 PM **Sun, Nov 24, 2024**. All booth spaces are outside, and all vendors must tie tents down and anchor their trucks/vans. Trucks/Vans SHALL NOT block walking space for customers. Booth fees are NON*REFUNDABLE.

BOOTHS: No lighting, electricity, water or security will be guaranteed. Vendors MUST keep their areas clean of debris and trash at all times. Event staff will not be liable for any losses or damages of any kind that occur at your booth. Absolutely no subletting or donating booth in whole or in part without prior written consent from event staff. *NO exceptions regarding subletting. Food vendors must provide their own setup (tents, generators, tarps, or similar covering to protect surfaces of the grounds from grease related cooking spills). No cleaning of any equipment on site. DO NOT pour any grease down the City of Orlando drainage! Take all grease to our disposal site on the premise. All refills of propane, gasses must be filled off site. **The Orange County Health Department will conduct mandatory food safety inspections.** Proof of \$1 Million Dollar Insurance Liability Coverage is to be submitted to Westlakes Events listing the following: **Westlakes Events, 2122 Piedmont Street, Orlando, FL 32805;** and **City of Orlando, 400 S. Orange Ave, Orlando, FL.** If you do not submit your Certificate of Insurance (COI), vendor will not be assigned a space and will NOT be able to vend. NO EXCEPTIONS.

RESTRICTIONS: No Alcoholic Beverages allowed. Westlakes Events respects trademark, copyright, and intellectual property rights. No "unlicensed, illegal, pirated, unauthorized" items will be permitted. Such items include audiotapes, videotapes, or any other merchandise of a "bootleg/duplicate/knockoff" nature. You agree to fully indemnify and defend Westlakes Events, its officers, directors and employees against any claims or actions relating to the presence of any such merchandise at your vending space. Gas grills only NO charcoal grills allowed. Tents must be WEIGHTED NO stakes allowed. Do not dump trash in dumpsters that you have not been given permission to use. Any violations may be subject to non-participation in future events. An appointed dumpster, portable toilets and grease trap will be on site for vendors' use.

- A valid City of Orlando and Orange County Business Tax Receipt (BTR).
- For Orange County Business Tax Receipts, call 407.434.0312 Option 2.
- State License from Florida DBPR (Department of Business & Professional Regulation) for selling drinks and food items. (This can be purchased on site for the Florida Blue Florida Classic).
- Peddlers cannot be located on city property or within the city's right-of-way (street, sidewalk, etc.).
- The average fee for a peddler is \$75.13.
- Forms of payment: Cash, checks, cashier's checks, money orders and debit/credit cards.
